Terms and conditions for the expression interest for construction of shopping Complex at Kumarhatti, Dagshai Cantt.

Technical Bid


1. The companies/approved architectures have to give their full detail alongwith the work/projects carried out by them supported with documentary evidence in technical bid.
2. The companies/ approved architectures have to give the status of their projects at present in a technical bid.
3. The companies/approved architectures can also give the new concept of designing the Shopping Complex to be adopted. They may also enclosed any document/ technology regarding Shopping Complex in technical bid.

Financial Bid

1. The companies/approved architectures have to give the financial bid to prepare the detailed project report of Shopping Complex to be constructed at Kumarhatti, Dagshai Cantt.

General Conditions

1. Cantt Board Dagshai has the right to accept or reject any bid. The Cantt Board Dagshai is not bound to accept the lowest bid as the bid will be approved by the Board after taking consideration of the technical/financial bid submitted by the bidders.
2. The successful company/approved architecture will have to deposit security amount fixed by the Board after approval by deposit-at-call or in shape of FDR of any Nationalized Bank pledged in favour of Chief Executive Officer, Cantt Board Dagshai within 10 days of the date of acceptance, which will refunded after the completion of the contract if not otherwise forfeited under conditions of agreement.
3. The successful company/approved architecture will have to execute an agreement on a Non- judicial Stamp Paper of appropriate value within 10 days of acceptance of tender.
4. Conditional tenders will not be accepted.
5. The companies/approved architectures have to give three different proposals/designs of Shopping Complex after the approval of the bid.
6. After approving the drawing/design the approved companies/ architecture have to give the complete estimates, drawing and structural design, drawing duly vetted from the competent Govt. authority /recognized Engineering College.
7. If the contractor fails to execute any work entrusted to him within prescribed time. The Chief Executive Officer will be at liberty to get the work executed through any other agency at risk and cost of the contractor and if the security falls short the contractor will pay the difference in cash.
8. Income Tax, GST, Water charges and other taxes /charges as applicable under rule will be deducted from the bills of the contractor.
